

## Access Court Documents and Filings from anywhere in Westlaw Canada

This month, a new link is being added to the top of every Westlaw Canada screen. The **COURT DOCS** link will make it simple to search the various Court Documents on Westlaw Canada. Access to Westlaw Canada's 90,000+ actual court **Pleadings, Motions, Facta** and **Insolvency Filings** will be just a few clicks away.



Simply click the **COURT DOCS** link in the top navigation bar. You will be presented with a selection screen where you'll choose from the drop-down menu the type of document you wish to search. The screen will display either additional topical areas available, or relevant links. Once you've checked off all your selections, click the **Search** button to go to the appropriate template where you'll enter your query.
