

WestlawCarswell Quick Reference Card Pay-Per-View Documents (warnings and prices)

Overview

WestlawCarswell is an open research service where users can dip outside their subscription into other services; however, a warning screen appears before your transaction is completed, allowing you to cancel the transaction.

Carswell **invoices** you the charge for any database you access **outside your subscription** or for any functionality which is not part of your subscription.

Find Transactions

What is a Find transaction? A Find transaction occurs when you click a blue hypertext link within a document (see Figure 1) or a document link from the Related Info tab (see Figure 2).

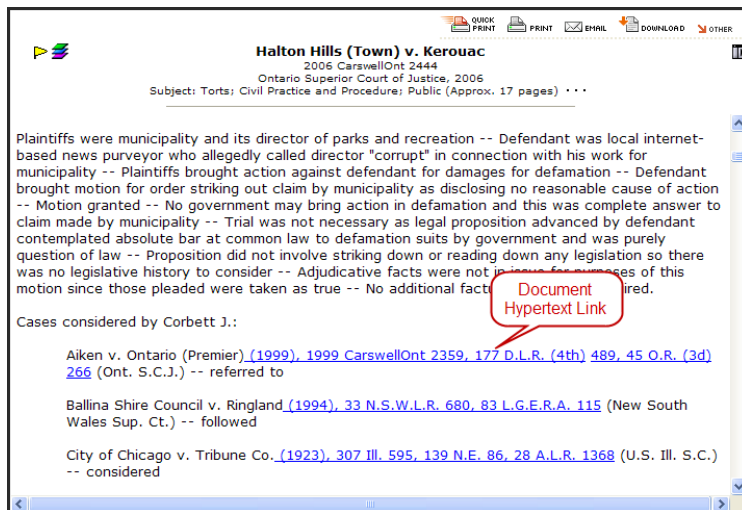

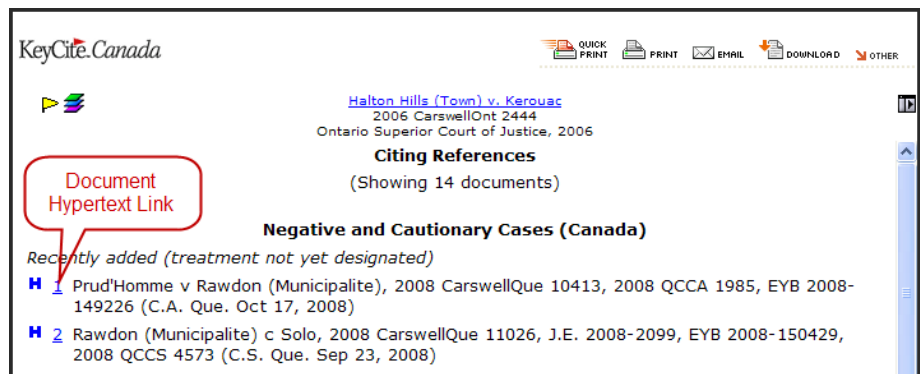

Generally speaking, Find transactions are charged at \$5.00 per Find; however, some exceptions apply. Incurring a Find transaction for precedent documents (pleadings, motions, facta, motion/application facta) is higher and the charge depends on the type of document found. The charge for estate planning, administration and litigation authored forms in Estates&TrustsSource is also higher. Please refer to the chart found at www.WestlawCarswell.com/transpricing for these prices.

Note: Find transactions for all international databases are charged at \$5.00 per Find.

Clicking a document hypertext link (Find) retrieves the following warning screen:

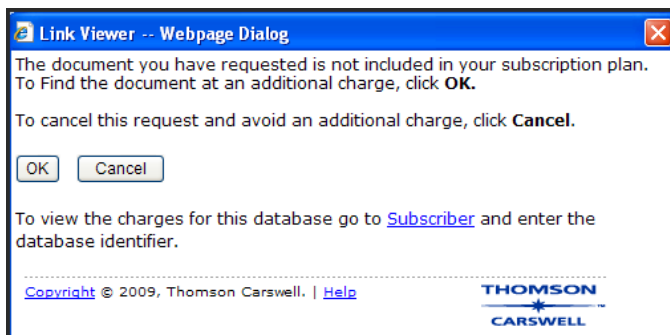

Click **OK** to accept the charge or click **Cancel** to cancel the transaction.

Search Transactions

When you run a search in a database that is outside of your subscription, a warning screen appears along with the database identifier for that database.

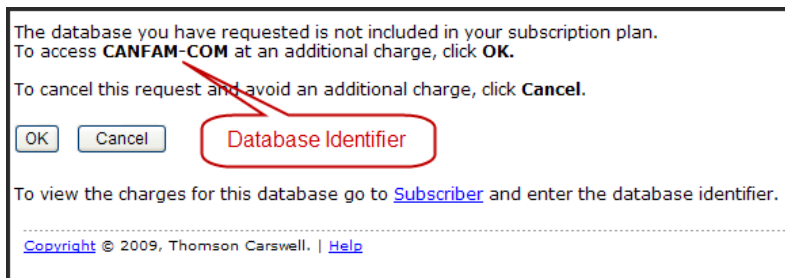

To determine the charge for running the search follow these steps:

1. Highlight the database identifier.
2. Right-click the identifier and from the pop-up menu, select **Copy**.

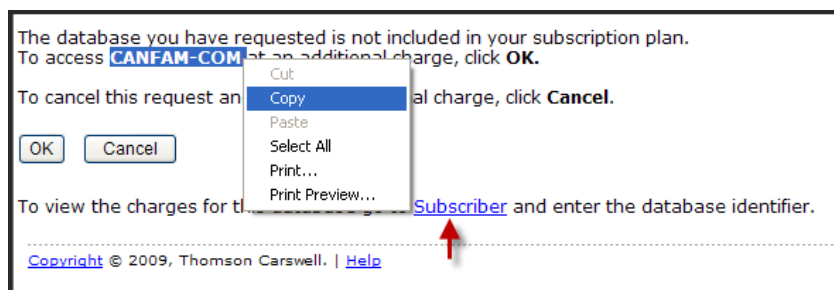

3. Click the Subscriber link at the bottom of the warning screen.
4. Paste the database identifier into the **Database Identifier** field.
5. Click **Search**.
